2. Crocker/Chesterton Compost, Tower St & Joilet Ave, Chesterton, IN 46304
3. Portage Compost, 6451 US HWY 12, Portage, IN 46368
4. Boone Grove Compost, 546 S 400W, Valparaiso, IN 46383

The Recycling & Waste Reduction District of Porter County is seeking quotes to grind organic brush and wood waste and/or removal of material at four different locations in Porter County. The locations are listed below along with the site specific requirements for grinding and disposal.

Valparaiso Compost, 2150 W Lincolnway, Valparaiso, IN 46383

- Grind all logs and 10% of brush to a finished product for mulch approximately 2" screen size.
- Pile the finished material on site where identified by management.
- Grind the balance of all the brush to a size which makes it manageable for removal from the site and haul the material from the site within 2 weeks after grinding is complete.
- Break out price per load.

Crocker/Chesterton Compost, Tower St & Joilet Ave, Chesterton, IN 46304

- Grind all the brush to a size which makes it manageable for removal from the site and haul the material from the site within 2 weeks after grinding is complete.
- Break out price per load.

Portage Compost, 6451 US HWY 12, Portage, IN 46368

- Grind all the brush to a size which makes it manageable for removal from the site and haul the material from the site within 2 weeks.
- Break out price per load.

Boone Grove Compost, 546 S 400W, Valparaiso, IN 46383

- Grind approximately 150 yards of brush to a finished product for mulch approximately 2" screen size.
- Pile the finished material on site where directed by management.
- Grind all the remaining brush to a size which makes it manageable for removal from the site and haul the material from the site within 2 weeks after grinding is complete.
- Break out price per load.

- Quotes will specify start date for grinding.
- Each of these sites receive organic wood waste and brush daily; include costs to cover the added material that will come in between today and the start of grinding. Exclude costs for major storms which would necessitate a separate quote.
- **Quotes are due in a sealed envelope by 10:00 a.m., Thursday, May 25, 2023 at the District offices located at 155 Indiana Avenue, Suite 314, Valparaiso, IN 46383.**
- The quotes will be opened at the District office by the Executive Director and the Operator and the public is able to attend the opening.
- The District will review the quotes with representatives from Boone Grove, Chesterton, Portage and Valparaiso to determine the best quote for each location.
- Service providers will be made aware of the results by Thursday, June 1, 2023.
- Enclose proof of liability, comprehensive and workers compensation insurance.
